Cleburne County Farmers Market Rules/Regulations

1. _____ Hours of OPERATIONS: The market will be open 2 days a week. Tuesday 11 a.m. until 6 p.m. and Saturdays 8 a.m. until 1 p.m.
2. _____ FEES: 10% of the days take no more than \$10 will be charged to use the Cleburne County Farmers Market. Fees will be paid in advance or days of to the Cleburne County Chamber of Commerce.
3. _____ Growing/Production Requirements: You must grow or produce your own products on your land or rented land. A producer is a person who grows or makes the product and may also include the producer's immediate family, partners, or employees upon prior approval by the Market Manager or Farmers Market Committee. However, a farmer is allowed to purchase produce for sale at the Cleburne County Farmers Market if two requirements are followed:
 - a. The farmer buys no more than 50% of the total amount of produce sold for the year.
 - b. The farmer cannot buy and re-sell any produce that another county farmer grows.
4. _____ PERMITS: If you are selling produce, you must have an Alabama Grower's Permit, which can be obtained from any Extension System office in Alabama. The Cleburne County Extension Office is located next to the nursing home in Heflin at 72 Brockford Road.
5. _____ The farmer may not sell any produce until the opening time.
6. _____ The market is a place of business; therefore, please act accordingly. No shouting out prices or any other negative comments at the market. All profane, abusive, discourteous or boisterous language and/or conduct at or about the market area are prohibited.
7. _____ If you have a question about pricing, contact the Chamber of Commerce or Rhonda Green.
8. _____ Growers who use the market for sale of produce are subject to field inspections by the Farmers Market Committee to verify the source of produce for sale.
9. _____ All sales from tables only. No permanent stands.

10. _____ Participants are responsible for keeping the area clean.

11. _____ The market manager or market committee has the right to ask a vendor or consumer to leave if necessary.

LIABILITY

Neither the Cleburne County Chamber of Commerce, Cleburne County Commission, the City of Heflin, nor the Cleburne County Extension Office is responsible for bodily injury, loss of equipment, personal losses, accidents, etc., which occur at the Farmers Market or on Premises. No liability is accepted by the Cleburne County Chamber of Commerce, Cleburne County Commission, the City of Heflin, or Cleburne County Extension Office.
