- **REGISTRATION:** Monday, April 8, 2019 at Cleburne County Chamber from 3:00p-6:30pm. You may pick up your number and turn in photos on Sunday, April 14th from 12pm - 1pm at the Heflin Armory. The pageant begins at 2:00pm. Schedules will be ready on Friday during registration.
- **PHOTOGENIC:** Photos for photogenic competition must be turned in by 1:00pm on Sunday, April 14, 2019. Entries are welcome until that time. There will be a photogenic winner in each age category. Photos should be no smaller than 5x7.
- **TALENT:** Talent will be an optional event and will not count toward your age group score.
- **THIS IS A NATURAL PAGEANT:** Sundresses, cowboy boots, sandals, ponytails, etc. are what the judges are looking for. **NO GLITTER AND GLAMOUR.** No traditional pageant gowns are allowed.
